You are instructed to bring a model of your choosing for the completion of your case studies. The model ideally will receive toxin treatment and dermal filler from start to finish by the same delegate

The session will be a half day, with delegates either attending the morning or afternoon session.


The other delegates can observe the treatment from start to finish, including photographs, consent taking, EMLA application, treatment planning, and notes.

Following the clinical development workshop, the delegates are encouraged to write case studies using their gathered images and experiences.



## **DELEGATE INFORMATION**

#### **OUTLINE OF THE DAY**

Welcome to the Clinical Development Day, designed to culminate your Level 7 Diploma in Clinical Aesthetic Injectable Therapies. This day is your opportunity to refine and demonstrate the skills you've developed through numerous training days, mentoring sessions, and academic learning. You'll discuss, plan, record, and execute a complete treatment plan from start to finish.

#### **ARRIVAL AND INTRODUCTION**

- Your trainer will greet you and outline the day for you and two other Level 7 colleagues.
- Following this briefing, you will privately plan your treatment with your patient, whom you are asked to bring along for the day.

### TREATMENT PLANNING

- Use the provided faculty iPad with our software to carry out the medical history, consent, and photographs needed for treatment.
- Apply the topical anaesthetic to your patient, if appropriate.
- Your case should ideally incorporate a combination of neurotoxin and dermal filler.
- Present your case to the trainer and other delegates. You can support this with images and paperwork or through an informal discussion.

#### **TREATMENT EXECUTION**

Once the treatment plan is decided upon, you will take your patient to the treatment room. Note that your patients' timing will be allocated before the day, as shown in the agenda below.

- Carry out all aspects of the treatment plan under the guidance and support of your trainer. The treatment must be completed within 60 minutes.
- Take postoperative photographs and document the details of the products used on the AA iPad. Provide aftercare instructions and ensure the patient is happy with the outcomes.
- Observation and Learning
- The remainder of the session will be spent observing your colleagues' rationale for treatment planning and their treatments from start to finish.
- Record any further treatments completed by your colleagues as observed treatments for your logbook.

#### AIMS OF THE SESSION

Experience an Aesthetic Appointment: From start to finish, understand the flow of a treatment session.
